4. FIRST-AID MEASURES

First Aid Measures

- Skin Contact** Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower. Wash contaminated clothing before reuse. If irritation persists, seek medical attention.
- Inhalation** Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Immediately call a poison center or doctor/physician.
- Ingestion** Do not induce vomiting. Give large quantities of water. If available, give several glasses of milk or acidic beverages (tomato or orange juice, carbonated soft drinks). Never give anything by mouth to an unconscious person. If vomiting occurs spontaneously, keep head below hips to prevent aspiration. Seek medical attention immediately.

Most important symptoms and effects

- Symptoms** Causes severe skin burns and eye damage. Ingestion can cause severe burns and complete tissue perforation of mucous membranes of the mouth, throat, esophagus, and stomach if swallowed. Inhalation of low concentrations may cause mild irritation to eyes, nose, and throat. High concentrations may result in headache, drowsiness, and central nervous system depression.
